## **Mission Restore our Ocean and Waters Forum 2025 (3rd Mission Forum) Draft Programme**

**Format:** In person, (web streamed) - interpretation: FR - DE - EN - IT - ES - NL - PT - EL (other EU languages tbc)

**Date:** 4 March 2025

**Venue:** Charlemagne Building, Brussels

**Scope:** The third Annual Forum of the Mission “Restore our Ocean and Waters” aims to celebrate and take stock of the Mission’s progress and major achievements by 2025, to give voice to the broad Mission communities engaged to date and further mobilise relevant actors around key Mission deliverables and to discuss the needs and strategic steps for reaching the 2030 Mission targets.

The event will showcase the broad mobilisation as well as the concrete research and innovation (R&I) solutions developed under the Mission and contributing towards its objectives. It will discuss how key stakeholders, including but not limited to regions, local authorities and the private sectors are involved in implementing the Mission and how different streams of finance are being mobilised to support the scaling and deployment of solutions for reaching the Mission objectives: to protect and restore marine and freshwater ecosystems and biodiversity, boost coastal resilience, eliminate pollution, and make the blue economy climate-neutral and circular and competitive. Following the 2023 assessment of EU Missions, the event will be an opportunity to discuss the strategic focus of the Mission until 2030, and the necessary steps for the deployment, replication and scaling of innovative solutions developed by the Mission.

The Mission Forum will bring together key stakeholders to:

- Present the progress of the Mission mobilisation to date and the buy-in to the Mission from key stakeholders at national, regional and local level, including through the Mission projects and Charter actions;
- Showcase concrete examples of innovative solutions developed and deployed under the Mission and related initiatives;
- Give voice to the Mission communities and discuss strategic priorities and needs for the Mission implementation at basin level, and the necessary next steps for the

systematic deployment of innovative solutions to restore our ocean and waters across the EU;

- Explore and define how the Mission can actively contribute in the short-, medium- and long-term to future EU priorities including the European Ocean Pact, the EU Ocean R&I strategy and the European Water Resilience Strategy.
- Further build a Mission community and discuss securing co-investments from EU, national, regional, local and private sources to reach the 2030 targets.

**Targeted stakeholders:** Member States and Associated Countries, relevant third countries and international organisations, regional and local authorities, representatives of sea and river basins, cities, ports, islands, fisheries and conservation communities, shipping, academia and education, industry, businesses, investors, philanthropists, NGOs and representatives of civil society including youth - all the communities engaged in the Mission.

The Forum will be preceded by a matchmaking event on 3 March and a series of events will take place during the European Ocean Days, linking the Mission to new main EU initiatives such as the upcoming European Ocean Pact and the European Water Resilience Strategy.
